Production tracking shall be signed off by Stout superintendent and City official weekly. Invoices shall be sent weekly.

Common exclusions may include the following:- Ripping, blasting, licensed staking and layout, permits, private locates, hidden or buried debris if any; rock excavation; dust suppression, compaction testing, traffic control, dewatering, landscaping, plantings, retaining walls.




